

## 2017 TEMPO<sup>®</sup> “Get Up and Win” Summer Contest OFFICIAL CONTEST RULES & REGULATIONS

The 2017 TEMPO<sup>®</sup> “Get Up and Win” Summer Contest (the “**Contest**”) is sponsored by Federated Co-operatives Limited (the “**Sponsor**”). The Contest begins 12:00 am, Central Standard Time May 15, 2017 (the “**Contest Start Date**”) and ends 11:59 pm Central Standard Time July 10, 2017 (the “**Contest Closing Date**”), known as the “**Contest Period**”.

**General Contest Information:** The Contest is being played at approximately 109 participating TEMPO<sup>®</sup> Dealer locations in the provinces of Ontario, Manitoba, Saskatchewan, Alberta, British Columbia, and Yukon Territory (“**Participating Locations**”).

### 1. HOW TO ENTER:

Each TEMPO<sup>®</sup> Dealer has an “Official Contest Stamp” that they will apply to the back of the sales receipt. Fill in the entry for details of: name, address, and telephone number. Deposit the entry in the “Official Entry Box”. All Contest entries will be submitted by the TEMPO<sup>®</sup> Dealer to the Sponsor (subject to verification by the Sponsor).

Obtain one (1) Entry Ticket from any cashier or authorized personnel every time you make a qualifying purchase at a Participating Location. Total limit one (1) Entry Ticket with each qualifying purchase transaction per twenty-four (24) hour period, regardless of the number of items included in the transaction. **Purchases of bus passes, gift cards, event tickets, passes and lottery tickets, alcoholic beverages, cigarettes, tobacco products, money orders or money transfers, and any other items that are legally prohibited by the Province where the transaction occurs alone DO NOT qualify you to receive an Entry Ticket.**

**NO PURCHASE NECESSARY.** A purchase will not increase your chance of winning. Complete the entry form or print your name, address and daytime telephone number on a plain piece of paper and send a self-addressed, stamped envelope to:

Enter as often as you wish beginning the Contest Start Date but each entry must be mailed in a separate envelope bearing sufficient postage. All entries must be received on or before the Contest Closing Date.

### 2. ELIGIBILITY:

To enter the Contest and be eligible to win, a person must be a resident of British Columbia, Alberta, Saskatchewan, Manitoba, Ontario, or Yukon Territory, and the age of majority in the jurisdiction in which he or she resides. Employees of the Sponsor, board members of the Sponsor, members of the immediate family of an employee of the Sponsor, those domiciled with an employee of the Sponsor, and employees of the Sponsor’s affiliates, agents, member retail co-operatives, independent judging

organizations, consulting, advertising and promotional agencies are not eligible to participate in the Contest, or win prizes in the Contest. Immediate family includes parents, siblings, children, and spouses.

The chances of being selected are dependent upon the total number of eligible entries received during the Contest Period. The Prize Winner will be required to sign a Statement of Compliance, Release and Indemnity Agreement.

#### **4. PRIZE WINNER:**

Prize Winners will be determined by a random drawing on August 1, 2017 in Saskatoon, Saskatchewan from among all eligible entries received on or before the Contest Closing Date; the first Prize Winner drawn shall choose one (1) Grand Prize from amongst the two (2) Grand Prizes, the second Prize Winner drawn shall receive the remaining of the two (2) Grand Prizes. Five (5) Secondary Prize Winners will be drawn to receive Broil King Barbeques; an additional five (5) Secondary Prize Winners will be drawn to receive Apple iPad Pro, as described in the Prizes.

Selected entrants will be contacted by telephone within seven days of the draw date. If a selected entrant cannot be contacted within 7 days of the draw date his/her entry will be disqualified and another entrant will be randomly selected. To be declared a Prize Winner, the selected entrant must (1) correctly answer a mathematical skill testing question to be administered via telephone, mail or email; and (2) complete, sign and return a Statement of Compliance, Release and Indemnity Agreement to the Sponsor within 14 days of receipt of written prize notification or prize will be forfeited and an alternate Prize Winner selected. Under no circumstances will the Sponsor, its member retail co-operatives, subsidiaries, affiliates, independent contractors, and their respective directors, officers, employees, and agents, including advertising and promotional agencies, be responsible for any injuries, loss or damages of any kind (compensatory, direct, incidental, indirect, consequential or otherwise) with respect to or in any way arising from, this Contest or the prize awarded. In no event shall the Sponsor be required to award more prizes than what is indicated in these Official Rules or award the prizes otherwise than in accordance with these Official Rules.

The Sponsor, Federated Co-operatives Limited, respects your right to privacy. Personal information collected is not sold, rented, or loaned to any third parties.
